American taxpayers are quite interested in knowing how banks have used the money that Treasury has invested under the Capital Purchase Program (CPP) and Community Development Capital Initiative (CDCI). We were able to continue offering the full suite of loan products to our customer base because of the capital infusion through CPP, with gross loans increasing in 2011 by \$2.98 million, or 4.3%.
